#### ITEM 3 – BULLARD CREEK RANCH, UNIT 3 – FINAL PLAT – APPROVED

On motion by Mayor Pro Tem Coe, seconded by Councilmember Cowart and carried unanimously, the Final Plat for Bullard Creek Ranch, Unit 3, was approved with the plat having been corrected according to the conditional approval of the Planning and Zoning Commission on May 23,

2022, that all lot sizes meet minimum 9,000 sq. ft., (2 lots did not) before final approval by City Council. (At the time the Preliminary Plat for this subdivision was approved, the minimum lot size was 9,000 sq. ft.)

It was noted that a temporary turnaround had been negotiated with the adjacent property owner for the current end of Stagecoach Bend.
