Christmas Kickoff Vendor Agreement

This agreement is between the City of Bullard and the person whose name appears below, hereinafter referred to as Exhibitor. The general rules of Christmas Kickoff are incorporated into and made a part of this agreement and shall be binding on the parties hereto:

1. Exhibitor agrees to display merchandise in an attractive and professional manner.
2. Any objects found to be objectionable or unacceptable by the City of Bullard must be removed upon request. Booth exhibits shall not include any political material, or materials which the City of Bullard deems to be objectionable.
3. Exhibitors must protect their exhibits, merchandise, and furniture, fixtures, from natural elements, such as wind, rain, hail, and other damaging occurrences.
4. Exhibitors are not allowed to use, sell, or advertise Christmas Kickoff on anything sold, as the City of Bullard, sponsor of the event has that right.
5. Exhibitors agree to assume all liability for damages or loss caused to the premises or their exhibit area by reason of their exhibit and agree to indemnify and hold harmless Christmas Kickoff and the City of Bullard, its staff, officers, and volunteers for liability which might ensue by reason of his/her exhibit or presence at the event.
6. Exhibitors shall indemnify the sponsor against all liability resulting from negligence of the exhibitor, their agents or employees and shall reimburse the sponsor for any loss or expense incurred by reason of negligence.
7. Exhibitors may not assign this contract or their space or sublet all or any part of their space.
8. Exhibitors are responsible for all items in their booth and all damages to all items in their booth. Christmas Kickoff and the City of Bullard are not responsible and do not guarantee against loss or damage due to theft, fire, wind, hail, rain, accident, sunlight, cold, or injury or any other acts of God.
9. The sponsor reserves the right to reject or prohibit any exhibit, proposed exhibit or part thereof, including with limitation, any person, articles, conduct, printed matter, catalogues or souvenirs that, in its opinion are not suitable to and in keeping with the character of Christmas Kickoff event. The decision of the City of Bullard is final.
10. **Set up of your booth can be no earlier than 8:00 AM, on December 2nd and must be set up before 2:00 PM. Break down of booth cannot be any earlier than 9:00 PM. No exceptions. No vehicles will be allowed in the exhibitors' sections during the festival.**
11. No refunds will be made once payment has been submitted to City of Bullard. No exceptions.
12. Christmas Kickoff may be cancelled prior to commencement due to acts of God or other actions that may endanger any participants or exhibitors.
